#### Senator Gail Davenport, District 44, D-Jonesboro

On Monday, January 11, the 156<sup>th</sup> Georgia General Assembly convened for its first legislative session. I will be serving as a member on the following committees: Appropriations, Retirement, State Institutions and Property, Natural Resources and the Environment, and Vice Chair of the Urban Affairs Committee.

My priority today is to get all persons in my district and the state of Georgia vaccinated for COVID-19.

## I will work diligently to advance the Georgia Senate Democratic Caucus 2021 legislative agenda which includes the following:

- 1. Raise the minimum wage to \$15/hour
- 2. Expand rural broadband so all Georgians have access to high speed internet.
- 3. Implement paid sick and family leave so people can afford to care for sick family members.
- 4. Create a state retirement plan for workers that don't already have retirement accounts through work.
- 5. Stimulate the economy and support families by creating child care scholarships so families never have to spend more than 7% of their income on child care.
- 6. Support seniors by mandating that state retirement systems provide a cost of living adjustment every year unless the state is in a fiscal emergency.
- 7. Pass comprehensive police and criminal justice reform so everyone is treated the same regardless of race or other characteristics.
- 8. Reintroduce the Georgia Justice Act to:
  - a. Require all police to wear and actually use body cameras.
  - b. Limit police chases to situations involving kidnapping or imminent violence so that people, including other drivers on the road, aren't put in danger over minor offenses.
  - c. Prohibit racial profiling and require departments to record the details of every traffic stop.
  - d. Ban rubber bullets for law enforcement to stop the brutal injuries caused by these weapons.
  - e. Ban chokeholds so that we don't have another murder like that of George Floyd.
  - f. Limit no knock warrants to specific circumstances when necessary to avoid violence to eliminate the kind of situation that led to the murder of Breonna Taylor.
  - g. Repeal the stand your ground law that encourages people to shoot first and ask questions later.
- 9. Pass redistricting reform so that voters choose their legislators instead of legislators choosing their voters.
- 10. Require equity in hiring for top state offices.
- 11. Expand Medicaid to cover almost 500,000 uninsured Georgians.
- 12. Oppose attacks on public education such as school vouchers and attempts to punish schools for operating virtually during a pandemic.
- 13. Raise teachers' pay by implementing a tobacco tax to discourage smoking and fund the raises.
- 14. Establish a Community Schools program with state level grants for struggling schools to hire resource coordinators to find community resources to help students.
- 15. Adequately fund schools so that, at least, the full Quality Basic Education formula is fully funded.
- 16. Allow Georgia residents in the DACA program to pay in-state tuition.
- 17. Enact and actually fund a needs based HOPE scholarship to join the other 48 states and DC
- 18. Require coal ash to be transferred to modern, lined landfills just like all other waste.
- 19. Expand access to the ballot through initiatives such as: Same day voter registration, automatic voter registration, an option to permanently vote by mail, a requirement that everyone early voting location have a dropbox, allowing counties to start counting mail votes early so the winner is determined faster, and allow poll workers to be from any county.

It is my honor to serve you and I look forward to sending updates during the Session.



## Rep. Sandra Scott Pre-Files 23 Bills for House District 76

ATLANTA – State Representative Sandra Scott (D-Rex) recently pre-filed 23 House bills ahead of the 2021 legislative session, which convened on Monday, Jan. 11.

"Of the legislation I introduce each year, 85 percent of it comes from citizens within District 76 and across the state, as well as talk radio and conferences that I attend on a yearly basis," said Rep. Scott.

"I want to encourage my constituents to please contact me if they have any questions about this legislation, especially in regards to how it may benefit our local communities."

During this legislative session, Rep. Scott plans to continue to introduce legislation that could have major impacts in House District 76. Rep. Scott also encourages constituents to participate in future town hall meetings to discuss proposed legislation.

Some of the legislation that Rep. Scott is eager to share with her constituents would address educational needs in District 76. House Bill 10 would direct the state to provide additional resources to students living in poverty. Scott also pre-filed House Bill 7, which seeks to provide greater access to higher-education opportunities to foster students and students with unstable housing. House Bill 9 would authorize the state to develop guidelines for telehealth services in Georgia schools that would provide mental health and behavioral health services.

Rep. Scott also seeks to address police and community relations in District 76. House Bill 15 would require police departments to provide de-escalation training to law enforcement officers. House Bill 17 would prohibit racial profiling by law enforcement officers and agencies, and House Bill 18 would require law enforcement agencies to provide body cameras to on-duty law enforcements officers. House Bill 20 seeks to increase accountability among Georgia coroners when investigating officer-involved deaths. And, House Bill 21 would prohibit citizens from making falsified 9-1-1 calls.

She also pre-filed House Bill 22, which would require any housing authority in Georgia to develop greater housing access opportunities to veterans in unstable housing, as well as House Bill 57, which would authorize the state to develop and implement breast milk storage policies in penal institutions.

#### **HB 36**

Assessing Indoor Air quality in Public Building reducing asthma and other respiratory diseases

#### **CAP ON INSULIN**

This bills puts a cap on out of pocket costs for insulin.

#### **HB 40**

Reducing toxic chemicals in consumer products (furniture, child care seats, firefighters foam)

#### **HB 58 WOMEN'S CARES ACT**

This bill provides that women who have been arrested are offered pregnancy testing upon detention, receive prenatal care and enacts a provision regarding delayed sentencing for postpartum female inmates.
